On August 9th, 2018 at approximately 3:30 PM, Captain Lyons and I responded to Hudson County Vocational School located at 8511 Tonnelle Avenue on a report of a belated theft. Upon arrival we were met by Mrs. Amy Lin-Rodriguez, the acting Superintendent. Mrs. Lin-Rodriguez informed us that a school employee by the name of Graciela Rubet had taken several items out of different lockers that did not belong to her.

Mrs. Lin-Rodriguez explained that another school employee, Mr. Edward Sellmeyer, had placed a bag containing various gift cards and other items into an unsecured locker on Friday June 22nd, 2018. When Mr. Sellmeyer returned to retrieve the items from the locker the following week, he discovered the items to be gone. Mr. Sellmeyer informed the school administration, at which point they began their own investigation.

Through the school surveillance camera's Mrs. Lin-Rodriguez was able to identify Rubet as the female who enters the locker and takes the gift bag, Rubet is also seen on surveillance removing another item from a different locker, however it is unknown what was taken from the second locker. On surveillance video Rubet proceeds to walk down the hallway back to her office with the gift bag. Rubet goes into her office, drops the bag off, and then comes back out of the office. Mrs. Lin-Rodriguez was able to provide me with a copy of the video surveillance.

I attempted to contact Mr. Sellmeyer via cellphone [REDACTED] to inquire the exact contents of the bag, however several attempts to contact him were unsuccessful. Mrs. Lin-Rodriguez informed me that the contents of the gift bag were to be raffled off at a charity event, and the value of the items were approximately \$200.00-\$300.00. Mrs. Lin-Rodriguez informed me that at this time, she would like to pursue criminal complaints against Rubet. I downloaded a copy of the surveillance video onto a DVD-R drive and placed it into the Bar Code Evidence Analysis Statistics and Tracking System.

On August 16th, 2018 at approximately 3:00 PM, I responded to 1 Dinosaur Way, Secaucus NJ to speak with the Hudson County Schools of Technology Business Administrator Nicholas Fargo. Upon arrival I was met by Mr. Fargo. The following is a brief synopsis of Mr. Fargo's voluntary audio statement.

Mr. Fargo informed me that he was tasked to review the surveillance cameras from June 22nd, 2018 in regards to a theft from a locker. Upon reviewing the cameras Mr. Fargo obtained video surveillance of an employee by the name of Mr. Ed Sellmeyer place a blue gift bag inside of a locker. Mr. Fargo observed a female on video entering the locker and removing the bag from the locker. Mr. Fargo informed me the contents of that gift bag were for a golf charity event and contained golf shirts, golf balls, souvenirs, pens, corkscrews, and possibly other items. Mr. Fargo informed me that he was able to positively identify Graciela Rubet in the video because he has worked there for twelve years and has seen her over one hundred times and interacted with her. Mr. Fargo informed me that the school would like to pursue a criminal complaint against Rubet for the Theft.

I was also given a copy of more surveillance video by Mr. Michael Jimenez, the Hudson County Schools of Technology union labor attorney showing Mr. Sellmeyer placing the gift bag inside of the locker. The voluntary audio statement and the newly obtained surveillance video was downloaded onto a DVD-R disk and placed into the Bar Code Evidence Analysis Statistics and Tracking System. Both items were subsequently stored in property and evidence. Based upon the totality of the circumstances and the evidence against Rubet, I contacted Hudson County Assistant Prosecutor Campbell. Assistant Prosecutor Campbell was advised of the facts of the case and informed me that I have enough probable cause to charge Rubet with Theft.

On August 29th, 2018 at approximately 2:30 PM, Graciela Rubet and her attorney came in to police headquarters. I escorted the two to the interview room while it was audio and video recording. Rubet's attorney, Paul Tyshenko, advised me that Rubet will not be providing a voluntary statement today. I obliged and escorted Rubet into the processing room to be booked and photographed on the charge of theft. I read Rubet her miranda rights, to which she verbally acknowledge she understood. Rubet was checked ATS, ACS, SCIC, and NCIC for any outstanding wants or warrants, with negative results. Rubet was fingerprinted and photographed without incident. Rubet was charged with theft, a crime of the fourth degree and released on complaint summons [REDACTED] with a pending court date of September 12, 2018 at 10:00 AM in Hudson County Superior Court.
